





MCS Services Limited (MCS Services, Company, ASX: MSG) is pleased to present its Activities Report and Appendix 4C for the three months ending 30 June 2023 (Period).

Cash and net receivables as at 30 June 2023 totalled \$2.6 million (31 March 2023 \$2.5 million) comprising cash of \$1.8 million (31 March 2023 \$1.5 million) and net receivables of \$0.8 million (31 March 2023 \$1.0 million).



OPERATIONS UPDATE

During the Period the Company:

- Commenced a new contract providing 24/7 uniformed security and patrols during the construction of a 850 person mine-site accommodation facility in the South West region of WA
- Lodged a number of security and traffic management tenders, the results of which are due for release subsequent to the Period-end.

ACQUISITION AND WORKING CAPITAL FUNDING OF HIGHWAYS TRAFFIC

During the previous Period, and as announced on 20th October 2022, the Company completed the acquisition of Highways Traffic Pty Ltd ("Highways"), a traffic management company, effective midnight 16th October 2022.

The acquisition was structured such that working capital (including Cash and Accounts Receivable, net of Accounts Payable and other liabilities) as at completion accrued to the vendors. As such, the Company arranged an Invoice Finance facility (\$1.5m limit) with National Australia Bank to fund, where needed, the working capital requirements of Highways in the post-Completion period. As at the end of the Period the Company had drawn down net \$1.4m (\$1.1m 31 March 2023) on the Invoice Finance Facility. As at the end of the Period Highway Traffic had Accounts Receivable of \$1.8 million (\$1.9 million 31 March 2023)

GROWTH OPPORTUNITIES

Acquisition Growth:

The Company continues to assess the expansion of its operations in the Perth metropolitan area, regional Western Australia and interstate through the identification and acquisition of suitable targets. It may progress these opportunities if they are value accretive to shareholders and consistent with the Company's strategy.

Organic Growth:

The Company has security operating licenses for Western Australia, South Australia, Victoria, South Wales, ACT and Queensland.

The Company continues to seek further organic growth opportunities in its specialist security (and, recently, traffic management) segments, including but not limited to leveraging its reputation with existing clients to obtain work at additional locations. The Company is also assessing the addition of new verticals to its business.



CORPORATE

During the Period the Company:

announced to shareholders its intention to commence an on-market share buyback of up to 10% (approximately 19 million ordinary shares) of its issued capital over the next 12 months, to be funded from existing cashflows. In this regard, during the Period the Company bought back and cancelled 400,000 of its ordinary fully paid shares at \$0.025 per share for a total consideration of \$10,000;

Arranged a \$0.65m flexible secured vehicle-finance loan facility with National Australia Bank, to fund a rolling improvement / replacement program for the Highways Traffic operational vehicle fleet. The program allows for a rolling retirement of older vehicles and a reduction in vehicle rental costs. As at 30 June 2023 the facility had been drawn down by \$0.25m
